| | Cllr Thornby explained that the telephone box restoration works are underway. There is an issue with door closure but once this has been resolved the shelving work will be undertaken. Listed building consent is required for the glazing to be changed from saying 'TELEPHONE' to 'BRABOURNE'. | | |
| | An issue regarding water pressure was brought to the attention of the Council. Cllr Spokes had spoken to a technician and the pressure is woefully low. It was agreed that Cllr Spokes would gather facts on the issue and that the Council would assist residents where possible. | | |

| | The Chairman allowed Cllr Brian Collins (County Councillor) to address the Parish Council under this item. Cllr Collins was invited to submit future regular reports if he wished to do so. | | |

| 6. | Reports from Local Organisations | | |
| | Allotments Society Cllr Thornby reported that the annual barbecue was held on the 5th of July. The weather was not kind, thanks extended to Stephen and Anita Saunders who did the catering, Bernard Farrant provided the meat and a small profit was made. This was a good social event. There was also an extraordinary meeting of the society to change the wording of the constitution to allow for online banking. The hosepipe trial continues and the current hose pipe ban does not apply to allotments, but allotment holders have nevertheless been encouraged to use water sparingly. The Cubs recently attended the allotments and had a very pleasant evening; one person gave up their plot but a new plot holder was found immediately and again all plots are filled. The composting toilet is still causing concern; it has been decided that it will be pumped out and advice from the manufacturer is to be sought. Allotment holders continue to have a successful harvest. | | |

Community Led Plan (CLP)

The CLP met on the 10th of June, the bracken by the playing field will need to be removed by chemical which will kill the wildflowers there too. There seems to be no other option as it is growing so thick. The CLP is looking for new projects. The repairs to the bench at Ramstone Close are ongoing, as are the remedial works to Hoskins Pond. Sales at the community day raised £45.50, the money in the bank is to be spent on the bollards by the Playing Field entrance. Potholes continue to be reported and the photo journal project is to take place over the winter months. It was considered that a donation to Saint Mary's, Smeeth was appropriate following use of their notice board at the Community Day.

The Clerk had been approached about the quality of pothole repairs. Brabourne Parish Council has nothing to add as Cllr Collins is already investigating the case. The Parish Council would suggest that the CLP approach Kent Highways with any repair concerns.

Playing Field

The AGM was held in June. The officers remain the same and minutes of the meeting will be circulated in due course. Quotations for replacement play equipment are being sought. The next Committee meeting is on 28 July 2025.

Village Hall

The Treasurer thanked the Parish Council for their monetary support. The new door is arriving on the 24th of July and Openreach will be installing Wi-Fi on the 25th of July. 5 new members for the Committee have come forward. Thanks were extended to the parish news for the article that was printed.

Any other reports

A Member of the public suggested that the telephone box could be turned into a nature informative box. Posts could be put up about how to look after bee life and nature with QR codes and maps. It was suggested that envelopes could be placed on the windows but this may require listed building consent. Further detail will be requested. It was agreed that the idea would be considered and the Clerk is to contact Ashford Borough Council to see if a transparent insert would require listed building consent.
